

MINUTES AND PROCEEDINGS OF A REGULAR MEETING OF THE BUTLER COUNTY BOARD OF SUPERVISORS HELD ON DECEMBER 1, 2020.

With limited public access to the courthouse due to COVID-19, this meeting was held telephonically with the public able to participate on a limited basis. This complies with Iowa Code section 21.8 that outlines the guidelines to hold an electronic meeting when there are valid concerns that an in-person meeting is "impossible or impractical".

Meeting called to order at 9:00 a.m. by Chairman Tom Heidenwirth with member Greg Barnett present and Rusty Eddy present telephonically.

Minutes of the previous meeting were read. Moved by Barnett, second by Heidenwirth to approve. All ayes. Motion carried.

Public comment was received by John Zimmerman, Greene, Iowa. He thinks the Board needs to formally accept County Attorney Greg Lievens' letter of resignation. Board agreed to formally accept at meeting of December 8, 2020.

Public Health Director Jennifer Becker reported 6 new positive cases of COVID-19 with 7 recovered, 7 hospitalized, 9 total deaths and a 20.1% positivity rate.

Board set December 22, 2020 at 9:15 a.m. as the date and time for a public hearing with the intent to fill the Butler County Attorney position by appointment.

Moved by Barnett, second by Heidenwirth to approve claims. All ayes. Motion carried.
